The Lexington Blueberry Festival will be held at Community Park, 200 Plymouth Street, in Lexington Ohio.

For Profit groups that would like to set up a display, promote, or sell their services, perform demonstrations, or highlight any acceptable community activity at the festival are encouraged to apply. The goal of the festival is to provide family fun.

All outside vendors spots are 10'x10' and all festival tent and pavilion spots are 8'x8' if more space is needed fee's will be adjusted to fit size of space. Table rental is \$20 each for duration of festival. Chair rental is \$5 each for duration of festival All monies paid for vendors spots, table or chair rental are non refundable

For Arts and Craft vendor status the items can be either made by you or hand made by a third party but may not include branded companies- IE (Origami Owl, Thirty One, Scentsy, Tastefully Simple, etc.) These type sales would only be eligible for a Business entry.

We will not provide special lighting - electric will be very limited

All vendors must comply with the following:

- Limited space availability
- Not responsible for any theft, damage.
- MUST include a signed liability waiver
- May leave material set up over night
- Festival Committee has final say as to appropriateness of items on display.
- **Setup is Wed Aug 16th** from 9am to 4pm
- MUST abide by attached rules

15th Annual LEXINGTON BLUEBERRY FESTIVAL August 17-20, 2017 Vendor Rules

Dear Attendee,

The 14th annual Lexington Blueberry Festival takes place August 17 through August 20, 2017. Like last year, the festival will take place at the Lexington Community Park off of Plymouth Street in Lexington, Ohio.

Applications are due before August 1, 2017. The Lexington Blueberry Festival Committee will make the determination as to whether or not it will accept a late application based on equity, space, and the reasons given for the late application.

BOOTH AND LOCATION INFORMATION

Blueberry Festival hours begin on Thursday, at 4:00 P.M. and end on Sunday, at 6:00 P.M. You are required to set up your booth or location between the hours of 9:00 A.M. and 4:00 P.M. on Wednesday, August 16, 2016. In addition, you are expected to have your booth open and manned at all times during festival hours which are as follows: Thursday 4:00 P.M. to 11:00 P.M.; Friday 4:00 P.M. to 11:00 P.M.; Saturday 10:00 A.M. to 11:00 P.M.; and Sunday 10:00 A.M. to 6:00 P.M.

OUR RULES AND REGULATIONS

1. The Lexington Blueberry Festival does not permit solicitations of any kind on festival premises unless you are under contract to do so.
2. The Lexington Blueberry Festival does not permit any other business other than what is indicated on your signed contract.
3. The Lexington Blueberry Festival takes place outdoors. You must prepare accordingly for all weather conditions.
4. The Lexington Blueberry Festival prohibits any sales outside your assigned vendor location unless under contract to do so.
5. The Lexington Blueberry Festival prohibits any moving or subletting of any or all of your assigned location.
6. The Lexington Blueberry Festival will provide access to electricity if you are under contract for such access. However, you must supply your own electrical cords to access the electricity.
7. The Lexington Blueberry Festival prohibits motor vehicles of any kind except those supplied by the Festival during Festival hours.
8. The Lexington Blueberry Festival prohibits firearms, deadly weapons, or dangerous ordnances. Unless otherwise authorized by law, no person shall knowingly possess, have under the person's control, convey, or attempt to convey a deadly weapon or dangerous ordnance on Festival premises.
9. The Lexington Blueberry Festival prohibits drugs or alcohol on Festival premises.
10. The Lexington Blueberry Festival and those associated with the Festival are NOT responsible for any injury, damage, or loss incurred as a result of your association and connection with the Lexington Blueberry Festival.
11. No vendor shall be permitted to give away food related items to attract traffic to their booth. Our food vendors pay a premium to have exclusivity of such items including but not limited to popcorn, cotton candy, bottled water, snow cones, etc. Except as it directly pertains to your booth merchandise, EXAMPLE: a vendor selling salsa mix would be permitted to offer samples of their product to promote the sale of such items.
12. Due to updated fire codes, you will not be able to extend your space beyond the confines of your booth. Booths are 10x10 outside and 8x8 inside. Should you need additional space, you must purchase an adjoining booth (no half booths will be sold).
13. The Lexington Blueberry Festival Committee has the right to interpret, amend, or alter these rules at any time.

The Lexington Blueberry Festival Committee **reserves the right to remove** items from display that it deems inappropriate or that conflict with the above listed rules. Individuals must abide by the Festival Rules and respect others at all time. Failure to do so could result in their permanent removal from the Lexington Blueberry Festival.
