### Car & Bike Show Details

Registered vehicles are invited to display classic, exotic, custom, truck, bike, project, specialty, and motorcycle entries. Judging, awards, door prizes, dash plaques, and Community Choice activities are planned during the show.

### Participants must comply with the following:

- One registration form is required for each vehicle entered.
- Check in before parking or displaying a vehicle.
- Vehicle must remain in the assigned display area until released.
- No burnouts, reckless driving, excessive revving, unsafe operation, alcohol, drugs, or weapons.
- Festival Committee has final say on approval, class placement, awards, and safety.
- Signed waiver is required with registration and payment.

## 2026 Car & Bike Show Rules & Guidelines

Friday, August 21, 2026 | Lexington Community Park | Lexington, OH

Please review these official Car & Bike Show Rules and Guidelines before submitting. Participation is subject to Festival approval, assigned space, class placement, and compliance with all Festival requirements.

**Registration Deadline: Before August 1, 2026 | Show Day: Friday, August 21, 2026**

Entries are subject to available space and Committee approval. Participants must check in as directed, display only in assigned areas, and keep vehicles parked safely during the event.

### Car & Bike Show Rules & Guidelines

Show Classes: Antiques, Muscle, Classic Car, JDM & Sport, Performance, Modified, Trucks, Lifted, Diesel, Bikes, Projects, and Special.

1. Entries are subject to Festival approval, available space, safety review, and final class placement by the Committee.
2. The show takes place outdoors. Participants must prepare for weather, grass, pavement, crowds, and changing event conditions.
3. Each owner or representative is responsible for the condition, security, insurance, operation, display, and supervision of their vehicle, trailer, and equipment.
4. Vehicles must be parked and displayed only in assigned show areas. Moving, relocating, or leaving the assigned area during restricted times requires Festival approval.
5. No burnouts, racing, reckless driving, excessive revving, unsafe operation, or other conduct that may endanger spectators, participants, property, or Festival operations.
6. Participants must keep display areas clean and use reasonable care to prevent fluid leaks, damage, litter, or hazards.
7. The Lexington Blueberry Festival and those associated with the Festival are NOT responsible for injury, damage, theft, loss, or weather-related impacts.
8. Firearms, deadly weapons, dangerous ordinances, drugs, and alcohol are prohibited on Festival premises unless otherwise authorized by law.
9. Participants must follow directions from Festival officials, police, fire, health, parking, and authorized event representatives.
10. Judging, class placement, award categories, door prizes, dash plaques, and Community Choice voting are subject to Committee decisions and availability.
11. Awards may include Best of Show Grand Trophy, class winners, Festival Choice, Best Paint, Best Engine, Best Interior, Judges Pick, Best Under-Carriage, dash plaques, and door prizes.
12. Community Choice voting will be collected by the posted deadline. Ballots must be returned to the designated Festival location for counting.
13. The Festival Committee has the right to interpret, amend, or alter these rules at any time for safety, fairness, or operational needs.
14. Failure to follow rules or official instructions may result in disqualification, removal from the show area, denial of future participation, or other Festival action.

### Awards, Judging & Community Choice

Judging considers overall presentation, condition, detail, craftsmanship, authenticity/quality, and curb appeal. Community Choice gives spectators an additional vote-based award; the posted show page notes ballots are due by 8:15 PM and the winner is announced at 8:30 PM.



# Waiver Of Liability & Indemnification

Please review and complete this waiver before submitting the Car & Bike Show registration. Subject to Festival approval, assigned space, class placement, and compliance with Festival requirements.

**Registration Deadline: Before August 1, 2026 | Show Day: Friday, August 21, 2026**

This waiver applies to the participant, vehicle owner, registrant, driver, representatives, passengers, guests, invitees, helpers, and any persons or entities acting on behalf of or in connection with the participant's show involvement.

## Waiver Of Liability & Indemnification

In consideration of being permitted to participate in, attend, display, register, operate, park, trailer, judge, volunteer, or otherwise take part in the Lexington Blueberry Festival of Ohio Car & Bike Show, including setup, check-in, load-in, display, awards, judging, tear-down, event grounds, streets, park areas, parking areas, facilities, utilities, or equipment, the undersigned agrees as follows:

The undersigned, for themselves and any organization, business, group, driver, owner, representative, passenger, helper, guest, invitee, heir, successor, and assign, understands that festival and vehicle show participation involves known and unknown risks, including injury, illness, death, property loss or damage, weather, crowds, vehicles, trailers, equipment, utilities, fire, fluids, slips, trips, falls, and acts or omissions of others. The undersigned voluntarily assumes all such risks.

To the fullest extent permitted by law, the undersigned releases, waives, discharges, and agrees not to sue the Lexington Blueberry Festival of Ohio, the Village of Lexington, and their directors, officers, committee members, employees, agents, representatives, volunteers, sponsors, affiliates, insurers, successors, assigns, and anyone acting on their behalf, collectively the Released Parties, for any claims, damages, losses, liabilities, costs, attorney fees, judgments, fines, penalties, or obligations arising from festival or show participation, attendance, operations, vehicle display, parking, judging, awards, or involvement.

The undersigned agrees to indemnify, defend, and hold harmless the Released Parties from any claims, damages, liabilities, losses, costs, attorney fees, judgments, fines, penalties, or obligations arising from the undersigned's acts, omissions, negligence, misconduct, vehicle operation, vehicle condition, trailers, displays, equipment, passengers, representatives, helpers, guests, invitees, or participation.

The undersigned acknowledges that the Released Parties make no promises, warranties, or guarantees regarding the condition, safety, security, suitability, accessibility, or fitness of any festival location, street, sidewalk, park area, parking area, show space, route, staging area, facility, utility connection, equipment, or other property. The undersigned accepts all such areas, facilities, equipment, and conditions as is and at their own risk.

The undersigned agrees to follow all festival rules, deadlines, safety requirements, vehicle show rules, local and state requirements, and directions from festival officials, the Village of Lexington, law enforcement, fire officials, health officials, or other authorized representatives. Festival decisions regarding participation, placement, approval, removal, safety, operations, judging, awards, and rule enforcement are final and binding to the fullest extent permitted by law.

The undersigned confirms they have authority to sign for themselves and, if applicable, their organization, business, group, drivers, owners, representatives, passengers, helpers, guests, invitees, and participants. The undersigned understands they are giving up certain legal rights, has read and understands this agreement, had the opportunity to seek legal advice, and signs voluntarily. This agreement is governed by Ohio law. Any dispute or legal action related to this agreement or festival participation shall be brought exclusively in the appropriate court in Richland County, Ohio, unless otherwise required by law. If any part is found invalid or unenforceable, the rest remains in effect to the fullest extent permitted by law.
