Waiver of Liability & Indemnification REQUIRED

This waiver applies to the applicant, parade entry, organization, group, unit, owners, officers, representatives, drivers, passengers, walkers, riders, performers, volunteers, helpers, invitees, guests, animals, and any other persons or entities acting on behalf of or in connection with the parade entry.

In consideration of being permitted to participate in, attend, stage, line up, travel, perform, display, sponsor, volunteer, or otherwise take part in the Lexington Blueberry Festival of Ohio Sunday Funday Parade, including setup, staging, lineup, parade route, reviewing area, tear-down, streets, sidewalks, park areas, facilities, vehicles, floats, trailers, animals, equipment, props, or other property, the undersigned agrees as follows:

The undersigned understands that parade participation involves known and unknown risks, including injury, illness, death, property loss or damage, weather, crowds, streets, curbs, vehicles, trailers, floats, animals, equipment, slips, trips, falls, visibility, traffic control, and acts or omissions of others. The undersigned voluntarily assumes all such risks.

To the fullest extent permitted by law, the undersigned releases, waives, discharges, and agrees not to sue the Lexington Blueberry Festival of Ohio, the Village of Lexington, and their directors, officers, committee members, employees, agents, representatives, volunteers, sponsors, affiliates, insurers, successors, assigns, and anyone acting on their behalf, collectively the Released Parties, for any claims, damages, losses, liabilities, costs, attorney fees, judgments, fines, penalties, or obligations arising from parade participation, attendance, staging, lineup, route travel, operations, or involvement.

The undersigned agrees to indemnify, defend, and hold harmless the Released Parties from any claims, damages, liabilities, losses, costs, attorney fees, judgments, fines, penalties, or obligations arising from the undersigned's acts, omissions, negligence, misconduct, entry operations, vehicle or float operation, equipment, trailers, animals, walkers, riders, passengers, helpers, representatives, guests, invitees, or participants.

The undersigned agrees to follow all Festival rules, deadlines, safety requirements, parade instructions, staging directions, local and state requirements, and directions from Festival officials, the Village of Lexington, law enforcement, fire officials, health officials, or other authorized representatives. Festival decisions regarding participation, placement, approval, removal, safety, operations, announcements, and rule enforcement are final and binding to the fullest extent permitted by law.

The undersigned confirms they have authority to sign for themselves and, if applicable, their organization, group, entry, drivers, riders, passengers, walkers, performers, volunteers, helpers, and participants. The undersigned understands they are giving up certain legal rights, has read and understands this agreement, had the opportunity to seek legal advice, and signs voluntarily.

This agreement is governed by Ohio law. Any dispute or legal action related to this agreement or parade participation shall be brought exclusively in the appropriate court in Richland County, Ohio, unless otherwise required by law. If any part is found invalid or unenforceable, the rest remains in effect to the fullest extent permitted by law.
